Subject: Progress report on FLCs/rural branches for the quarter ended March 2016

Dear Sir,

This has reference to the reports/returns submitted for quarter ended March 2016 on Financial Literacy activities conducted by FLCs and rural branches of banks as per circular dated January 14, 2016 on revised guidelines for FLCs.

We have observed that, in general, the FLCs have not been able to meet the minimum targets of conducting target-specific camps for the five targets groups (some FLCs have not conducted any camps). Further, rural branches in general have not been able to meet the target of either special camps or target-specific camps. Regional offices are advised to place the issue as an agenda item in the ensuing SLBC meetings and seek reasons/feedback from the banks on the issue.

After analysis at RO level, you may forward a detailed report incorporating the - a) accomplishments, b) deficiencies and c) feedback on the conduct of outdoor camps - by FLCs and rural branches in your jurisdiction.
